










OVERVIEW: POLAND AND CHINA

2019 was a very special time in terms of relations between the People's Republic of China and Poland. 70 years ago, on October 7th, 1949, Poland recognised the newly established People's Republic of China as one of the first in the world. Since then, bilateral relations between the two countries have been gradually improving. In 2016 President Andrzej Duda and President Xi Jinping signed a declaration that upgraded Poland-China ties to a comprehensive strategic partnership.

This particular moment is suitable to highlight the most important events of this blossoming relationship. The cooperation between Poland and the People's Republic of China is very close in the fields of economics, as well as culture, technology, and politics. Starting from the 1950s, Poland and the People's Republic of China have continuously defended each other's interests on the international stage. These events marked the beginning of forging a strong bond between the two countries.

In recent years, we have witnessed a serious intensification of the mutual support, sparking confidence in the profitability of the future relations between these two countries.



OVERVIEW: POLAND AND CHINA

Since Poland has been invited to participate in "16+1" regional cooperation framework in 2012, annual meetings have been held in order to discuss a wide range of investments in the fields of infrastructure, energy and transportation. In 2013 the first direct train railway cargo connection was established between Łódź and Chengdu, making it possible to deliver goods between countries with more than a thousand trains. Poland is only the second country in the EU that was allowed to export its apples to China with a total worth of 1 billion euro. Furthermore, Polish goods such as amber, dairy, meat, and alcohol have already made a name for themselves in China and enjoy increasing popularity.

The list of achievements in various aspects is immensely long and emphasizes the strength of cooperation between these two countries. According to Yao Dongye, the Deputy Chief of Mission at the Embassy of the People's Republic of China in Warsaw, the continuous success of Sino-Polish cooperation is due to the multiple similarities between Poland and China. Both countries can be characterised by their rich cultural heritage, sustainable economic growth and shared views on the importance of free trade. In light of reaching this impressive milestone in their relationship, Poland and the People's Republic of China can be proud of such an excellent cooperation and friendship which will hopefully strengthen even further in the upcoming decades.



MAIN IDEA OF THE PROJECT

Warsaw-Beijing Forum is a project created by the Students' Organization for Law and Economy of China. The major focus of the organization is to establish a strong, multidimensional connection between students from China University of Political Science and Law and the University of Warsaw. The goal is to give the participants an opportunity to acquire knowledge and experience during a series of lectures, meetings and workshops led by renowned experts. In order to build a strong liaison between future leaders, the Forum focuses on the exchange of knowledge and experiences regarding both business and culture, hence aiming to develop entrepreneurship and mutual understanding between the nations. In conclusion, our purpose is to impact international business, trade, and partnership of both countries.



BUSINESS ASPECT

The Forum has been sucsupported cessfully numerous global law firms, international corporations and think tanks. WARSAW-BEIJING FORUM 2018/2019

The tagline of the Sixth Edition of the Project was "Intelligence Approaching Business", a theme which highlighted the impact of new technologies and artificial intelligence on the Sino-Polish economic relations and legal regulations. We had an opportunity to discuss the most advanced methods of economic development and learn about exploiting the potential of the prosperous relations between Polish and Chinese entrepreneurs.

The aim of the Project was to show that both countries have much to offer on the technological field. Poland is widely considered as a country with rich legal traditions where innovative business flourishes, whereas China has established itself as one of the most technologically advanced countries and a key player in the development of artificial intelligence. Participants had an extraordinary opportunity to share their ideas on the outcomes of the fourth industrial revolution in various fields connected with the relations between Poland and China. The skills and knowledge they obtained will most certainly prove useful in today's fast evolving world.

This year's edition was enriched not only by workshops in Warsaw and Beijing, but also by meetings in Shanghai where students had an opportunity to get acquainted with the concept of online courts as well as the basics of comparative law.



THE WARSAW PART

The first part of the Project was held from the 20th to the 24th of May 2019. During their short stay in Warsaw, Chinese students had a busy schedule. The participants attended multiple meetings. Topics ranged from the aspects of new technologies and AI in Polish law to the M&As in the tech sector. The broad spectrum of discussed issues allowed the Chinese students to gain a better understanding of not only Polish law and economy, but also to discover fascinating aspects of Polish culture and language.



THE BEIJING PART

The second part of the Forum took place between 4th and 8th of November 2019. The participants gained knowledge of the impact of new technologies on the change of judiciary and had a chance to be on one of the world's first online court. Thanks to the visits in various law firms located in Beijing, they had an opportunity to learn about the details of practising law in China. The meetings provided them with unique insights on the digital era from the legal perspective as well as on AI and autonomous driving.

ACHIEVEMENTS OF THE SIXTH EDITION

Over the course of the past six years, Warsaw-Beijing Forum has made a significant impact. From a small students' organization, it evolved into the biggest project in the field of Sino - Polish relations. It is also one of the best students' projects on the scale of the whole country. The main idea of the project describes our ambitious vision for the future relations between Poland and China. The past six editions were an uncompromising success.



Warsaw-Beijing Forum was nominated for the best students' organization in multiple contests and got a number of grants for its operations. It attracted extensive media attention from nationwide internet portals and newspapers such as Rzeczpospolita, Interia.pl or Forsal.pl.

Furthermore, it took place under many honorary patronages of the most prominent public figures, such as the President of Warsaw, Hanna Gronkiewicz-Waltz and the President of Poland - Andrzei Duda.

Warsaw-Beijing Forum has also been awarded a grant from the Ministry of Science and Higher Education. The award allowed Warsaw-Beijing Forum members to organize the First Polish Academic Conference on Legal and Tax Issues of Trade between Poland and China. The event gave the listeners a chance to gain a deeper insight into one of the most important and intricate aspects of the Sino-Polish relations - taxation issues and tax law.



THE OPENING CEREMONY IN WARSAW

Monday, May 20th, 2019



The Sixth Edition of the Warsaw-Beijing Forum's theme was "Intelligence approaching business", therefore the Opening Conference took place in prof. Jan Baszkiewicz Assembly Hall, one of the most modern buildings on the University of Warsaw campus. Many distinguished guests honoured us with their presence and delivered opening speeches during the ceremony.

Monday, May 20th / Tuesday, May 21st, 2019



DLA PIPER

The lecture delivered by renowned specialists, Hanping Wen and Aleksandra Kalwasińska from the DLA Piper Law Firm, focused on detailed steps of launching a company in Poland. Firstly, the experts presented the legal overview of trading in Poland and the EU. Secondly, they explained the main types of business entities in Poland and its features. The experts also compared Polish and Chinese capital markets. Thirdly, the Chinese participants had an opportunity to ask their questions about doing business in Poland during a Q&A session.

TRINITY LAB

The participants had a chance to attend a lecture titled "The Values of the Nobility and its Relations with the Peasants in Poland". The seminar helped Chinese students to broaden their knowledge on historical events which had a major influence on the Polish Commonwealth's evolution into a modern society. Mr Piotr Frankowski explained the geopolitical consequences of Poland's position on the map. Moreover, he presented the historical and social roots of the women's position in the Polish society.





ACRO BIKE

The Forum had a chance to host Magdalena Gromniak and Tyler Shi, a Polish-Chinese couple who started a bike sharing company "Acro Bike" in Poland. Acro Bike implemented the business model of Chinese bike sharing corporations like Ofo or Mobike. The company is also investing in other personal mobility devices such as electric scooters. Thanks to the courtesy of the hosts, the participants of the Forum were given a brief introduction to the company's operations. Furthermore, they revealed some technical solutions behind the bike sharing business.

POLISH LESSON

Later that day our Chinese guests had an opportunity to get a little bit acquainted with the Polish language. The class was conducted by a Warsaw-Beijing Forum member, Mr Dariusz Skotarek, a linguist and a translator. The meeting started with the history of the Polish language and its place in the Indo-European family. Mr Skotarek showed that Polish and Chinese are similar in some aspects, for example in their mostly shared phonological repertoire. The lesson ended in a well-remembered moment of Polish and Chinese students singing a traditional Polish song in unison.



Wednesday, May 22rd, 2019



JGBS Biernat & Partners

Mr Kamil Biernat, the Managing Partner at JGBS Biernat & Partners prepared a case study concerning the challenges that Polish and Chinese companies face when cooperating with each other. The main part of the meeting was a series of workshops concerning the 1987 Polish-Chinese bilateral agreement on legal assistance in civil and criminal matters according to which any document drafted in one country is valid in the other and does not require additional legalization. During the lecture participants gained the knowledge on international contracts and Sino-Polish cooperation.

PIKMED

The lecture titled "Artificial Intelligence and blockchain technology as a component of Health Care and Environment Protection" was delivered by Mr Tomasz Szelągowski, the President of the Board of Polish Innovative Medical Cluster. The discussion revolved around 5G technology, internet of things, blockchain, artificial intelligence and wireless fidelity. The lecturer went into great detail when explaining the significance of adapting new legal regulations concerning new technologies.



DLA Piper

The copyright aspect of artificial intelligence was explained to us at the courtesy of experts from DLA Piper. The participants discussed the problem of the authorship attribution to work generated by artificial intelligence. The experts also analysed cases presented by the DLA Piper lawyers, for example the Next Rembrandt or the monkey selfie copyright dispute. The workshop proved beneficial in helping the participants to gain valuable knowledge on the legal issues of the new technology sector.

ACCENTURE

A senior manager at Accenture Applied Intelligence, Mr. Dominik Perykasza and Mr Olgierd Uziembło from the University of Warsaw delivered a lecture titled "Artificial Intelligence in China from European Perspective". The lecturers' main objective was to raise awareness on the subject of development of AI in China and its strategy of building a domestic AI industry. The speakers also outlined the differences between Chinese and European strategic plans for the development of AI, enumerating both the advantages and disadvantages of each.



Thursday, May 23rd, 2019



CLIFFORD CHANCE

The Warsaw-Beijing Forum participants had an opportunity to visit the Warsaw office of Clifford Chance law firm. At the beginning, the participants were acquainted with the history of the Clifford Chance development in Poland. Subsequently, the counsel at Clifford Chance, Mr Piotr Pogorzelski, delivered inspiring and thought-provoking lecture about white-collar crimes. Furthermore, he clarified the role of lawyers in such cases. Participants had a unique opportunity to gain practical information about white-collar crimes and had a glimpse at the company's future goals.

SDZLEGAL SCHINDHELM

Dr Agnieszka Łuszpak-Zając from our long-time partner and sponsor, SDZLEGAL SCHINDHELM, prepared a case study concerning trade agreements and the contractual boilerplate clauses. A crucial part of the meeting was teamwork. The students were divided into groups, each trying to draft a part of an agreement according to the given guidelines. Thanks to this extraordinary exercise, participants improved their understating of provisions used by Chinese partners. Moreover, the potential obstacles opportunities of the Sino-Polish cooperation were presented.



CMS LAW FIRM

Thanks to CMS Poland office, the event started with admiring a stunning view of the Warsaw panorama from a vantage point located in the company's building. Afterwards, the Partner in the Energy and Projects Department at CMS Poland, Mr Piotr Ciołkowski, conducted an inspiring meeting. Students gained knowledge not only about energy industry but also were familiarised with the profile of the company's activity. At the end of the event, the participants engaged in a Q&A session. Students had an opportunity to ask multiple questions, in particular focused on the energy sector.

CRUISE ON THE VISTULA RIVER

Due to the courtesy of the Warsaw Tourist Office, participants had a chance to admire breathtaking views of Warsaw. Firstly, the participants strolled around the Old Town and Krakowskie Przedmieście Street. During this sightseeing walk, a tour guide showed the students the most beautiful landmarks and let them in on fascinating stories about the city. At the very end of this exceptional tour, participants took a boat trip on the Vistula river. The scenery inspired the participants to share their impressions and get to know each other better.



Friday, May 24th, 2019



MAZARS

Mr Zhe Qiu, a Mazars specialist, led the meeting on investments in the region of Central and Eastern Europe. After a quick introduction, participants were briefed on economic differences between Poland and China. The speaker compared landmark investments in CEE with real property investments in China. The speech ended with an outline of tendencies on the mergers and acquisitions market in the CEE region, followed by a Q&A session. Nearly all of the participants flooded Mr Zhe Qiu with questions.

BIRD & BIRD

A series of workshops was held in cooperation with the international law firm Bird & Bird. The hosts, Mrs Daria Gęsicka and Mrs Izabela Kowalczuk-Pakuła, discussed contemporary issues related to intellectual property protection, Al development, and the data ownership in the network. Throughout the workshops a fruitful discussion was held on contemporary problems related to the IT law. This exchange of ideas has definitely encouraged participants to explore the nuances of the legal boundaries of technological progress.



CLOSING CEREMONY IN THE LINKLATERS WARSAW **BRANCH**

The closing ceremony was the cherry on top of our project. It took place in the lounge at the highest floor of the Q22 during a picturesque sunset, with the Warsaw skyline serving as a backdrop of our final meeting. It is also worth mentioning that Linklaters were the hosts of our closing ceremony for the second year in a row, a sign of a fruitful cooperation which will hopefully continue to grow in the years and editions to come.

Participants celebrated the time spent on the Warsaw-Beijing Forum events and lectures. Besides preparing a delicious dinner, our partner also provided us with some food for thought. We discussed different aspects of M&A in the technological sector from Chinese perspective with an expert in this field, Wojciech Podlasin, who was also a member of Linklaters Beijing. THE OPENING CEREMONY IN BEIJING

Monday, November 4th, 2019



Official opening of the Sixth Edition of the Warsaw-Beijing Forum took place in the conference hall of the Bupt Hotel. Not only participants of the project attended the conference, but also representatives of our partner universities.

The ceremony began with the opening speeches delivered by:

Alongside with a very warm welcoming of the guests, every single one of the speeches, no matter the authors' academic degree, was equally insightful and inspiring. THE BEIJING PART

Tuesday, November 5th / Wednesday, November 6th, 2019



MINSHENG BANK

On the second day of the Forum, the participants were invited to the headquarters of the China Minsheng Bank, the first private bank established in China. During the meeting, students had a unique opportunity to learn about the differences between private and public banks of China and the mechanism of collecting new clients. Furthermore, participants were familiarized with the matter of establishing trust fund in China. At the very end, participants could admire the Minsheng Bank art gallery and took part in traditional Chinese painting class.

DENTONS

Participants had an opportunity to visit the world's largest law firm - Dentons. By courtesy of the Senior Partner at Dentons Beijing office, Ms Yang Liu, students attended a brief lecture about mergers and acquisitions in China. The lecture was followed by a Q&A session, during which our participants were able to receive valuable knowledge about recent trends on the M&A market in China, inbound and outbound deals and venture capital fund-raising. It was the second consecutive year when participants of the Forum were hosted by Dentons Law Firm in Beijing.



SUPREME PEOPLE'S PROCURATORATE OF PRC

Visiting the Supreme People's Procuratore of the People's Republic of China gave an opportunity to meet with SPP's prosecutors: Zhang Xiaohan, Li Haoxin, and Gao Yifei, as well as with a CUPL professor Xue Xiaojian. During the visit, the members discussed various topics ranging from the powers and responsibilities of Polish judges, role of SPP in Chinese political system to different aspects of the criminal procedure in Poland and China. In the end the prosecutors gave the students a small tour around the building of the SPP.

LECTURE DIGITAL ERA - A LEGAL PERSPECTIVE

Participants of the Forum took part in two Oxford-style debates that were organised at CUPL. The discussions were moderated by prof. Shen Weiwei, Director of the Center for the Legal Studies on Big Data and Al. During the first part of the event, the students argued whether social media accounts should be inherited, e.g. by parents. The topic of the second debate was the problem of artificial intelligence and legal responsibility. The students had conducted a lively discussion which was praised and commented on by prof. Shen.



THE BEIJING PART

Thursday, November 7th / Friday, November 8th, 2019



BELT AND ROAD ARBITRATION INSTITUTIONS **ROUNDTABLE FORUM - CIETAC**

Participants of Warsaw Beijing Forum attended "Belt and Road Arbitration Institutions Roundtable Forum", held at CIETAC headquarters. The aim of the conference was to strengthen mutual trust and elaborate on the system of credibility for trade in the forthcoming decades. Various issues had been discussed together with e. g. Mr Marcin Jamka from SAKIG. The attendants also witnessed the announcement of the Beijing Consensus of Belt & Road Arbitration Institutions.

LECTURE ARTIFICIAL INTELLIGENCE AND AUTONOMOUS DRIVING

The lecture was provided by Ms. He Shanshan and Ms. Alice Xiang, Firstly, Ms. He Shanshan, the Director of Autonomous Driving Law Centre of Intelligent & Connected Mobility Academy presented development of autonomous cars and the balance between efficiency and safety in the process of designing such cars. Secondly, Ms. Alice Xiang discussed a problem of AI bias in regard to the autonomous cars. Finally, the two speakers engaged in a vigorous debate.



BEIJING INTERNET COURT

To experience new technology influence on the judicial system, Warsaw Beijing Forum participants visited Beijing Internet Court, an institution established in September 2018. Firstly, the students were shown an online litigation experience area where they could take part in a mock Internet trial. After that, the BIC judges demonstrated an online e-litigation platform. Finally, the participants engaged in a Q&A session with the judges during which they discussed various issues related to the BIC organisation and legal tech.

CLOSING CEREMONY

On our very last day in Beijing, Chinese students prepared a closing ceremony to summarize the past week filled with captivating meetings and lectures. The ceremony took place on the campus of the China University of Political Science and Law. During the event, distinguished professors gave their speeches focusing on the project, the idea of Sino-Polish cooperation and congratulated all the participants. Students exchanged their views on this project's edition and discussed further enhancing cooperation.



VISIT TO SHANGHAI

Monday, November 11th - Wednesday, November 13th, 2019

WORKSHOPS BY BIRD&BIRD

The cooperation of the Warsaw-Beijing Forum with the Bird&Bird law firm in the sixth edition brought a series of three workshops that took place in Shanghai. The substantive theme of the meetings was focused around making investments and opening business in China by foreign entities. 
